Outstanding students to get STB Scholarships to pursue Bachelor of Business (Tourism & Hospitality Management) at NTU's Nanyang Business School

The new Bachelor of Business (Tourism & Hospitality Management) offered by NTU's Nanyang Business School is supported by the Singapore Tourism Board (STB). STB will facilitate undergraduate internships and applied research projects through their network of international business travel and MICE (Meetings, Incentive Travel, Conventions and Exhibitions) organising companies, hotels, and other firms within the tourism and hospitality industry.

STB will also offer scholarships to outstanding students who wish to pursue a career in the tourism and hospitality sector

Eligibility Criteria

All GCE 'A' Level and Polytechnic graduates with outstanding academic achievements and impressive records of co-curricular activities are welcome to apply for the Scholarship.

The Scholarship is open to Singaporeans and Permanent Residents only.

Students under other scholarships are not eligible for the STB Scholarship. Students who are on bursaries or have taken other university loans are also not eligible.

Application Procedure & Period

Students who are interested in the STB Scholarship should send in their application when they apply for admission into NTU. Application can be made online at https://wis.ntu.edu.sg/pls/webexe/SCHLR_NANYANG_AUS.login

Application period for the scholarship are as follows:

- Polytechnic diploma applicants – 1 February to 21 February 2006.
- 'A' Level applicants - 1 March to 1 April 2006.

Applicants who are short-listed will be invited to an interview.

Terms & Conditions

The STB Scholarship covers the following:

- Tuition fee directly payable by students (after tuition grant)
- Living expenses of S\$6,000 per academic year

The Scholarship covers the entire duration of the undergraduate studies on the condition that the scholar maintains a minimum standard of academic performance. Yearly reviews will be conducted and the Scholarship will be withdrawn if the scholar's academic progress is not satisfactory.

The scholar will undergo at least one internship programme with STB or a company designated by STB during the study period. Upon graduation, he/she is also required to serve a three-year bond with any tourism-related company (such as hotels, attractions, conference or exhibition organisers, food and beverage or travel services) in Singapore.
