Important

- SDF Subsidy for the following pre-approved courses apply to Singaporeans and PRs from SMEs[^] only.
- The approved rate of subsidy is \$4.00 per training hour (inclusive of GST).

[^] *Small and Medium Enterprises (SMEs) are defined as companies with at least 30% local ownership, with fixed asset investments of not more than \$15 million and, if in the services sector, employment size of not more than 200.*

Step 1:

- Login to SDF EasyNet (www.sdf.gov.sg) using your company registered ID and password.
- Make on-line enrolment/application by clicking 'Make Enrolment'. Enrolment must be submitted at least one working day before the course commences.
- Search with your desired Course Title, or under Provider Name "Nanyang Technological University".
- Click on Add Trainee and enter your participant details. Repeat this step for multiple participants.
- Take note of your Entry Reference Number (e.g. APP-2009000123).

Step 2:

- Register online for the *same* course and *same* run-date from CCE's website (www.ntu.edu.sg/cce)

2. A confirmation email will be sent to your email address upon submission.

Payment and Fee Structure

Upon course confirmation, you will pay only the **Nett Course Fee** (i.e. the unsupported portion of course fees) for your eligible participant(s).

Example 1

A company that registers **2 participants** (1 Standard +1 Alumni) for a 2-day course (\$590.00) will pay this nett fee:

Participant 1: **\$534.00**

Participant 2: **\$427.20**

Total: **\$961.20 (w/GST)**

Example 2

A company that registers **3 participants** (2 Alumni + 1 Standard) for a 4-day course (\$1,180.00) will pay this nett fee:

Participant 1: **\$854.40**

Participant 2: **\$854.40**

Participant 3: **\$961.20***

Total: **\$2670.00 (w/GST)**

* *Group discount automatically applies to Participant 3*

Discount Definition

* Alumni Discount: Applies to all current NTU/NIE Alumni and Students. NRICs are used for verification with the NTU Registrar before the discount is granted.

* Group Discount: Applies to 3 or more registrants for the same course and at the same time.

General Info and Criteria

* SMEs must be registered or incorporated in Singapore.

* Participants must be company-sponsored & must be Singapore Citizens or Permanent Residents of Singapore.

* Participants must have achieved 75% attendance.

* Course fees listed in SDF EasyNet do not include Alumni or Group Discount, as well as prevailing GST.
