Tuition Fees for AY2009-10 freshmen

For students offered admission in AY2009-10, the annual tuition fee is fixed at the AY2009-10 rate for the duration of their degree programme.

For students who were offered admission in AY2009-10 and joined the university in AY2009-10, the university had deferred the increase in tuition fees for their first year of study in view of the difficult economic situation in 2009. For these students, their tuition fees for their first year of study followed the AY2008-09 cohort fees. However, the fees which these students will pay from AY2010-11 onwards are reflected in the table below.

The fees shown below will also be the fees applicable to students who were offered admission in AY2009-10 but who will join the university in AY2010-11 or AY2011-12.

- All amounts quoted are exclusive of GST.
- For students paying subsidised fees, GST on the subsidised fees and tuition grant are subsidised by MOE.
- For students paying non-subsidised fees, GST on the non-subsidised fees are to be borne by the student.
- For students who have exceeded the normal programme duration, they will no longer be eligible for the tuition grant and GST subsidy from MOE. NTU will however extend the same subsidised tuition fee to the student and GST on the tuition fee is to be borne by the student.

Notes on payment of fees

- 1. Students who do not sign the tuition grant agreement or who are not eligible for tuition grant will have to pay non-subsidised tuition fee.
- Fees (tuition fee and compulsory miscellaneous fees) are payable by students on a semester basis regardless of whether they are on Industrial Attachment, Overseas Exchange Programme, etc or otherwise during the semester.
- 3. Students who are completing one last subject in order to graduate, are also required to pay fees (tuition fee and compulsory miscellaneous fees) on a semester basis.
- 4. Students who withdraw or apply for leave of absence from the University two or more weeks after the commencement of a semester are liable for the payment of fees (tuition fee and other compulsory fees) for the whole semester.
- 5. National Servicemen whose enrolment in the University is delayed by one or two years because of their National Service commitment, are allowed to enjoy a one-year or two-year lag in the payment of their subsidised tuition fee. The fee payable will depend on the year that they had first accepted a place in the University. For example, if they were offered admission in AY2007 and had accepted the offer, they pay the subsidised tuition fee applicable for AY2007 when they join the University in AY 2009. If they had re-applied for a new programme in AY2008, they will still pay the subsidised tuition fee applicable for AY2007 regardless of the 2nd application outcome.
- 6. Office of Finance sends the electronic bill (E-bill) to undergraduates via their NTU student email account at the beginning of each semester. Upon notification, students are required to log on using their Student Link account to view and print their E-bill for record/payment.

Tuition Grant for AY2009-10

The Tuition Grant indicated in the table below is applicable for AY2009-10 for all subsidized undergraduates regardless of their year of admission.
