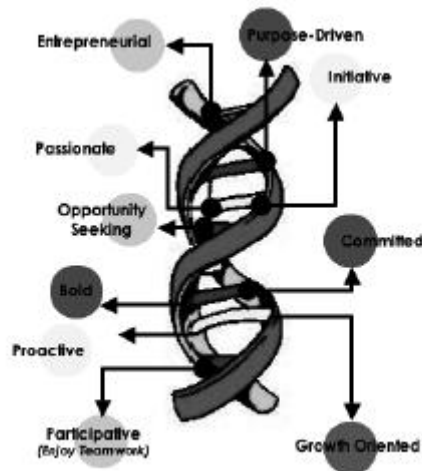
The Centre was established in January 2001, as a multidisciplinary university level centre, through the sponsorship of Nanyang Technological University and the Economic Development Board.
